PROMOTION EXAMINATION AGREEMENT

If at any time, I violate any of the above or following "*conditions*" expressly agreed upon between Dragon Tang Soo Do, my club, and myself, I hereby agree that Dragon Tang Soo Do and my club reserve the right to withdraw and revoke any rank and/or status.

Therefore, I expressly agree:

That I am prohibited from using any Tang Soo Do techniques unless it reasonably appears necessary to defend myself or another against an apparent threat of unlawful and immediate violence from another.

CONSENT FOR THE USE OF PHOTOGRAPHS AND/OR VIDEO
